## **ARTICLE I**

The exact name of the corporation is:

# SEASIDE SUSTAINABILITY, INC.

## **ARTICLE II**

The purpose of the corporation is to engage in the following business activities:

THE CORPORATION IS ORGANIZED AND SHALL BE OPERATED FOR EXCLUSIVELY CHARITA BLE AND EDUCATIONAL PURPOSES, INCLUDING EDUCATING THE PUBLIC WITH REGARD TO ENVIRONMENTAL AWARENESS AND THE PRESERVATION AND PROTECTION OF OUR OC EAN RESOURCES.

### **ARTICLE III**

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualifications and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

# **ARTICLE IV**

Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members, are as follows: (If there are no provisions state "NONE")

1. THE CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CAR RIED ON BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C)(3) OF THE INTERNAL REVENUE CODE. 2. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF ANY PRIVATE INDIVIDUAL, AND NO MEMBER, DIRECTOR, OFFICER OR EMPLOYEE OF THE CORPORATION SHALL RECEIVE ANY PROFIT OF ANY KIND EXCEPT REASONABLE COMPENSATION FOR SERVICES IN EFFECTING ITS CHARITABLE PURPOSES. 3. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION SHALL NOT PARTICIPATE IN ANY POLITICAL CAMPAIGN. 4. IN THE EVENT OF A DISSOLUTION OF THE CORPORATION, THE ASSETS SHALL BE DISTRIBUTED TO SUCH ORGANIZATION OR ORGANIZATIONS THAT ARE OPERATED FOR EXCLUSIVELY CHARITABLE PURPOSES AND WHICH AT THE DATE OF DISSOLUTION ARE DESCRIBED IN SECTION 501(C)(3) OF THE INTERNAL RE VENUE CODE.

Notes: The preceding four (4) atricles are considered to be permanent and may only be changed by filing appropriate Articles of Amendment.

#### **ARTICLE V**

The by-laws of the corporation have been duly adopted and the initial directors, president, treasurer and clerk or other presiding, financial or recording officers, whose names are set out on the following page, have been duly elected.

# **ARTICLE VI**

The effective date of organization of the corporation shall be the date approved and filed by the Secretary of the Commonwealth. If a *later* effective date is desired, specify such date which shall not be more than *thirty days* after the date of filing.
